I have been waiting to be able to get some answers on whether there will be a Craft Fair this year to update this site. There are three pieces that control the event. First, approval from Soroptimist International who control access to liability insurance. We have just received approval for events from them so that is good news. Then we need to have a venue; currently CV Starr is closed down and we have not heard when they will reopen. But most important, the City of Fort Bragg has to approve and allow Paul Bunyan Day events; at this point there has not been a decision on this.

So this is how I am going to proceed. If you are interested in attending the Fair if it is approved I just need an email from you telling me that you would like to attend. I will record you in a Vendor list and keep you updated as decisions are made by the City. It is looking hopeful but it will of course depend on events; we can hope things will keep approving. If the Fair does get scheduled I will ask for an application for any Vendor who has never attended this Fair. I have attached a copy for reference.

Your entry fee goes towards the funds raised by Soroptimist International of Fort Bragg and supports our various scholarships and community contributions, in particular Project Sanctuary, which offers a wide array of free services for Mendocino County victims of sexual assault and domestic violence.
