Dear Crafter:

Soroptimist International of Fort Bragg and Noyo Sunrise clubs are together sponsoring the 2026 **Labor Day** Crafts Fair on Saturday-Sunday, September 5-6, 2026.

Attached is an **entry form** for the fair. Fair hours are Sat. 10-6pm, and Sun. 10-4pm. Booth space is 10' x 10'; \$100 per space plus \$10/foot if extra requested; **advance payment with an entry form** guarantees a booth space and preference on requested location (first come-first served). Unreserved walk-in vendors will be accommodated on a space-available basis. Artists are obligated to stay both days barring emergencies or illness. There will be a security person to patrol overnight on Fri and Sat., but the fair assumes no liability for theft. So please secure your wares overnight.

All communication will be by email. Applications and payment will be acknowledged, and booth assignments given on or before the week prior to the fair. If you receive an acknowledgment of payment and the application, you can assume you are in the fair (unless told otherwise).

Setup is both Friday Sept. 4 (3-8pm) and Saturday Sept. 5 (7-10am). Booths are on the grassy area on the north side of the C.V. Starr Community Center; 300 South Lincoln Street (between Willow and the Maple), two blocks east of Harold Street. This location is a flat, clean, grassy area. There is no shade, so we advise you bring a tent/easy-up. Overnight Parking is available behind the C.V. Starr Center. Pets are allowed on leash and under control at all times.

All work must be handcrafted by the seller; you will be asked to remove any items that are not handcrafted. All participants need to provide their own display tables, chairs, easels, umbrellas, etc. There is no shade, so you will want to bring your own. You might want to bring a dolly as well if you have heavy items. We will provide a dolly but it gets heavy usage and you might prefer to have your own. Security would be provided on Friday and Saturday night.

We appreciate your interest in the Fair. This event is a major part in the success of our Paul Bunyan Days celebration. Your entry fee goes towards projects and scholarships of the Soroptimist International of Fort Bragg and Noyo Sunrise clubs. These clubs support , in particular Project Sanctuary, which offers a wide array of free services for Mendocino County victims of sexual assault and domestic violence.

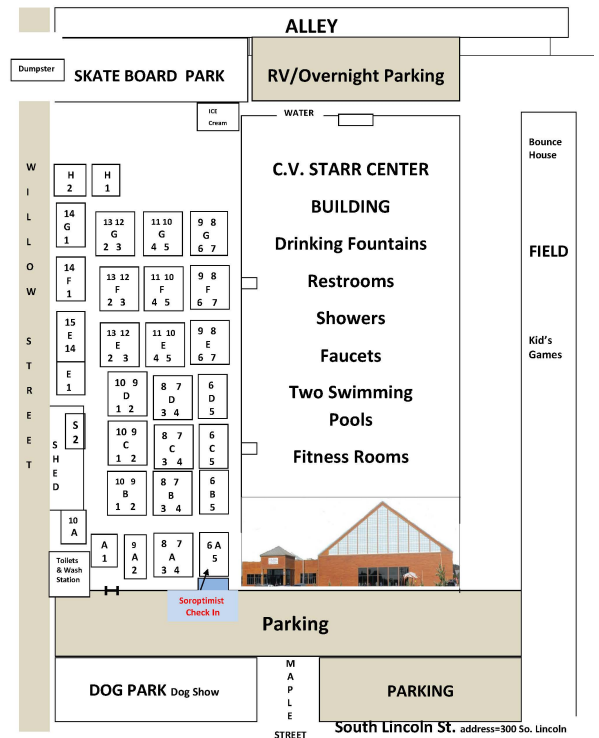
